Solicitors Report:

Item 1: Mr. O'Donnell stated that he cleared a lean and will provide information if necessary.

Item 2: Mr. O'Donnell stated that the Sugarloaf Township Ordinance issue was sent in accordance with the letter I received from their solicitor and I sent a copy to the Board. This is the Sugarloaf raise hike position. They want us to sit back and wait because they do not want to address the onlot sewer ordinance issue that is recommended by Entech. Conyngham has already adopted the ordinance and it is a part of its status.

Item 3: Mr. O'Donnell stated the Sunshine Act for holding Executive Session has an addition to it. This was adopted in October 2018 and it took 60 days to take affect that the purpose for holding an Executive Session can be to discuss, plan, or review matters that are deemed necessary for the safety of the public protection internet infrastructure for schools.

Engineer's Report:

Item 1: Mr. Gallagher asked that a letter be sent to the Sugarloaf Township from the Solicitor stating that this issue is not something that is coming out of nowhere, but they need to adopt the ordinance in order to meet up with the 537 Plan. If not the DEP will step in and we would just have to state that we tried to get them to update their ordinance and they refused to update the Sugarloaf Township Ordinance to meet the 537 Plan – Mr. Harrison states they will have to adopted the ordinance in order to accommodate the 537 Plan for Conyngham/Sugarloaf Twp. Sewer Project.

Item 2: Mr. Harrison stated that he has been working with Mr. Gregory (Manager) to try to come up with a rehab program and I was looking at this first year most of it will be to study because it does not pay to jump in and start fixing things until you have a handle on thing and you know where the flows are coming from. Mr. Harrison handed out a spread sheet with figures on cost also looking at CoStar's rates. Mr. Harrison stated these are really rough numbers, but I actually went through smoke testing, any down spouts that may be leaking these would be simple to go through and get that done and also doing house inspections. The lateral and CCTV we will do both of them together because the cost of doing the lateral and the CCTV separate would be more expense because you still have to put a camera down. The cost would be about \$300 per lateral. Every line should be televised every 10 years. We have all the mapping down pretty much and we are ready to set up putting cameras down. We have been doing GIS for a while now, but I can bring our GIS expert.



Mr. Olander so how many do you anticipate at this rate? Mr. Harrison it should be about 5 years and about \$300,000. Now this is just the study at this time. When we get into the sewer replacement it will probably be about couple hundred dollars a foot.

Item 3: Mr. Harrison handed out sheets on the Rain Gauges for \$1,400.00 for approval.
